







Quarter over Quarter & Year over Year Stock Indices Price Change

8/20/2018: CACI International, a Virgina based provider of information solutions to the federal government, considers acquisitions as among its top uses of cash, according to CEO Ken Asbury.

7/30/2018: **Equifax**, the Atlanta based provider of information solutions and human resources business process outsourcing services, is working on a pipeline of bolt-on opportunities, according to CEO Mark Begor. "The M&A machine was never turned off," he said. "But if you want to characterize that way, we've got it turned on meaning that our team is out there. We have monthly meetings on it. I meet with the team all the time, the team that works for me, that works on M&A, and we're in the marketplace."
