Key Highlights

The top subsector stock performer in Q2 2022 was institutions / workforce solutions, down 0.7% quarter-over-quarter

On average, EBITDA multiples for the subsectors decreased 0.6x from the prior quarter and decreased 1.2x on a year-over-year basis

COVID-19 Dips, Blips and Stimulus...the Long Tail of COVID-19's Impact on Education M&A

Many new COVID-19-related terms have entered our lexicon seamlessly over the last two years. Sadly, most seem likely to be part of our daily dialogue for years to come. "COVID-19-driven" alone has become a term we cannot escape, whether we are talking about the global economy, inflation or our kids' education experience for more than two years. As education mergers and acquisitions (M&A) practitioners, we find ourselves in daily conversations about our clients having to address COVID-19 dips, blips and stimulus benefits. We can say with almost 100% certainty that one of the first five questions we get about any client in the education space will address at least one of those COVID-19-related phenomena.

The COVID-19 Dip

Recessionary business declines are not a new thing, but declines (or "dips") caused by a pandemic are. Like so many industries, the onset of the pandemic shuttered education buildings across the world in March 2020. As a result, demand for so many of the services that help keep those schools functioning declined or even evaporated almost overnight. So, those businesses had some level of decline in performance while schools sorted out remote learning and what their ongoing COVID-19 strategy would be. The issue now though, is not whether those companies experienced a dip in performance, but whether or not they will fully bounce back from those dips and how long it may take to do so. We seem to get these sorts of questions ad nauseum on any business that showed a decline in 2020, and unfortunately, we do not see an end to those questions anytime soon. The honest answer for most is we still do not know for sure. If school districts proceed as planned, and we do not see another disruptive COVID-19 surge, 2022-2023 will be the first "normal" school year since 2018-2019. Maybe, a full school year relatively unimpacted by COVID-19 will put those questions to rest.

The COVID-19 Blip

Equally difficult to answer are questions around the bounce in performance that many companies experienced in the second half of 2020 and 2021. Any tech providers (just as Zoom did) became investment darlings. M&A for education technology (edtech) providers jumped to never-before-seen levels. Similarly, education service providers (tutoring, teacher support and virtual schools) became top-of-mind for investors looking to seize on a new education paradigm. It was not long, however, before those same investors started to question how sustainable these COVID-19 blips would be. We have spent an inordinate amount of time with investors trying to establish that these businesses are forever altered by the shifts that have taken place in education due to COVID-19. Unlike the COVID-19 dip phenomenon that may finally be put to rest with the 2022-2023 school year, it could be years before questions around the COVID-19 blip are fully put to bed. That said, digital learning is here to stay and we see that continuing to pervade investment decisions.

COVID-19 Stimulus

The other lingering effect of COVID-19 in the education M&A market has been and will continue to be stimulus funding. We have talked to dozens of active investors about their interest in the education market generally that have said they are concerned with the temporal impact of stimulus funding on many businesses, and therefore are highly unlikely to acquire or invest in those businesses. Spread across multiple funding bills, those stimulus dollars are likely to not be fully utilized until 2024. In many cases, schools and school districts have "accessed" those funds with no practical ability to actually put them to use. Similar to questions around the COVID-19 blip, it will be some time before concerns around temporary support from stimulus funds subside and we can return those discussions to true business fundamentals.

Like so many areas of our lives today, the vestiges of COVID-19 will remain for years (and probably decades) to come. We can only hope that COVID-19's impact on education M&A is a little more short lived, and that we can soon re-focus on the fundamentals of the education market and the businesses that support it. So many of them are having positive impacts on students and teachers and need support to push that mission forward. It will be a shame if the impact those businesses can have is stalled over fears related to the dips or blips they experienced during the pandemic.







Quarter-over-Quarter Price Performance




Quarter-over-Quarter Stock Indices Price Change
