


# Market Update







**Facilities Services** Q3 2022

## **Facilities Services Insights**

After a series of record-breaking quarters throughout 2021, Q3 2022 marks another slight deceleration in mergers and acquisitions (M&A) activity, approximately 7,500 deals closed, according to S&P Global. This represents a decrease of approximately 18% compared to the approximately 8,900 deals closed in the previous quarter. However, a decline in transaction activity is unsurprisingly due to the continuous re-balancing of M&A markets following the record-breaking pace of activity in 2021 and early 2022. Buyers, particularly financial sponsors, remain very active as they look to deploy an estimated approximately \$1 trillion of dry powder in the North American private equity (PE) markets. This pullback in activity from the record highs in 2021 was due to a combination of factors, including but not limited to, 1) increased financing costs due to interest rate hikes, 2) broader concerns about the macroeconomic environment, particularly inflation and 3) uncertainty surrounding geopolitical issues. However, we continue to see both strategic and financial acquirers showing a steady commitment to making investments when they are the right fit for strategic growth and strong returns.

There has also been continued activity within the facilities services sector, specifically within the U.S. market. During Q3 2022, PE-backed facilities services companies were particularly active acquirers. Companies, including Pueblo Mechanical & Controls (OMERS), Tech24 (HCI Equity) and Pye-Barker Fire & Safety (Altas Partners), completed acquisitions. As of Q3 2022, the Lincoln International facilities services index (12.3x EV/EBITDA) and S&P 1500 Environmental and Facilities Services Index (15.1x EV/EBITDA) are both valued at lower multiples relative to Q2 2022. Overall, we remain optimistic that the facilities services M&A market will continue to remain strong in 2022.























## About the Lincoln Facilities Services Index

The Lincoln facilities services index is a market cap-weighted, composite stock index similar to the S&P 500 Index. The index is prepared by first selecting a base period, in this case, Q4 2020, and totaling the market caps of the companies in this period. This period and the total market cap is set to a base index at 100%. Next, the current period's total market cap is calculated, divided by the base period's total market cap and then multiplied by the base index (100%).

Quarter-over-quarter indices for the S&P, S&P Environmental and Facilities Services and Lincoln facilities services decreased and the Lincoln facilities services index enterprise value / EBITDA trading multiples decreased by 0.2x from 12.5x to 12.3x.






#### Quarter-over-Quarter Stock Index Change

#### Heard on the Street

9/28/2022: Tech24 (HCI Equity Partners), a Greenville, South Carolinabased national provider of maintenance and repair services for foodservice and commercial heating, ventilation and air conditioning (HVAC) equipment, announced the acquisition of Allied Service Group. Allied is a provider of maintenance, repair and install services for foodservice and HVAC equipment in restaurants and grocery stores in the Tennessee and Mississippi markets and represents Tech24's 12th add-on acquisition under HCI Equity's ownership. In Q3 2022, Tech24 announced three other acquisitions: AmeriCold (8/28/2022), Arrowhead Commercial Equipment (8/28/2022) and TEMCO (7/26/2022). AmeriCold provides cold-side repair and installation services in the New York metro area, Washington D.C. and Southeast Florida, while Arrowhead and TEMCO strengthen Tech24's geographic presence in Arizona and Mississippi, respectively.

9/19/2022: ABM Industries (NYSE:ABM), the New York-based facilities services provider, noted no slowdown in acquisition opportunities as the company progresses towards its goal of adding approximately \$2 billion of acquisition revenue by 2025. In 2022, ABM acquired Able Services, Momentum and, most recently in Q3 2022, RavenVolt, which the company acquired for approximately \$170 million plus potential earn-out payments of up to \$280 million. Chief Executive Officer Scott Salmaris, noted ABM is seeing more caution in the marketplace but continues to see ample opportunity for tuck-in acquisitions that generate approximately \$100 million in revenue.

8/31/2022: Massey Services, a family-owned, Orlando, Florida-based provider of pest prevention, termite protection and landscaping services is seeking additional acquisitions in Tennessee and Virginia. In the last two years, Massey has completed eight acquisitions in existing and new markets, ranging in size from \$1 million to \$10 million, including two acquisitions in Tennessee and one in Virginia. Tony Massey,

Chief Executive Officer of Massey, noted the company is continuing to opportunistically seek acquisitions in additional states in existing geographies, namely Florida, Georgia, Louisiana, South Carolina, North Carolina and Oklahoma, and new geographies including Washington D.C. and Texas. In 2022, Massey expects to generate more than \$350 million of revenue with operating margins above 25%. Historically, the company has grown organically 8%-12% per year and an additional 2%-3% per year through acquisitions. Approximately 86% of the business is residential and operates via a network of 176 service centers.

8/25/2022: CenterOak Partners, the Dallas, Texas-based private equity firm, announced the formation of Turf Masters Lawn Care Services, a residential lawn services platform based out of Atlanta. The Turf Masters platform is formed via the combination of Turf Masters Lawncare, All Turf Holdings and Green Group Holdings. The existing owners and management teams will continue to be active members of the consolidated entity and Andy Kadrich, the founder of Turf Masters Lawncare will lead the platform as Chief Executive Officer. Turf Masters provides recurring lawn, tree and shrub care services for more than 100,000 customers annually and operates 20 branches across 10 states. CenterOak plans to support growth via increasing service offerings and pursuing add-on acquisitions across the fragmented lawncare industry.

8/6/2022: Pueblo Mechanical & Control, the Tuscon, Arizona-based provider of HVAC and mechanical services announced it was acquired by OMERS Private Equity from Huron Capital Partners. Jeff Kahn, Director at OMERS, notes that Pueblo is well-positioned to capitalize on secular trends towards energy efficiency, sustainability, decarbonization and digitization as potential areas of future growth, in addition to pursuing strategic M&A.


