Key Highlights


The top subsector stock performer in Q2 2019 was institutions / workforce solutions, up 2.0% quarter-overquarter

On average, EBITDA multiples for the subsectors decreased 0.3x from the prior quarter and were up 0.7x on a year-over-year basis

What Metric Suggests an Education Technology Company is 'Acquire-able'

Our friends at EdSurge recently published an article in which a very seasoned education buyer and seller, Peter Bencivenga, cites a single metric as the key to making an education SaaS business attractive to buyers. According to Bencivenga, this metric is customer retention, and the magic threshold is 90%. While we undoubtedly agree that customer (logo) retention is a critical metric for SaaS investors and buyers, we would humbly disagree that there is one single indicator that suggests a business is suddenly "worthy" of being acquired.

We are often asked by our clients and prospective clients what those key metrics or key performance indicators (KPIs) should be if they seek to maximize value in a new investment round or potential sale. There are any number of sources that will cite a variety of KPIs that purport to be specific to SaaS businesses or even to SaaS businesses in a particular vertical market. Having worked with dozens of SaaS providers in the education sector over the last 10+ years, we have distilled those KPIs into a framework that has become highly reliable in predicting valuation ranges. A summary version of that framework is illustrated below.




Market Valuation Range

While not exhaustive, the abbreviated framework above will provide a more fulsome view of likely market valuations than one single metric. Other key items in our framework, such as customer lifetime value, customer acquisition cost, etc., are not included in the abbreviated version above. Also embedded within our framework is a more nuanced version of the widely cited "Rule of 40" theory, which we will elaborate on in a future edition of our Market Update. The items we note above and in our comprehensive framework each reflect a particular element of the power of a SaaS business' customer value proposition, competitive market position and relative growth trajectory. In the end, these are the core tenets of any investment or acquisition thesis.

We would be happy to discuss in greater detail the framework we have developed and how it may help focus strategic decisions for growing SaaS enterprises.







6/27/19: GEMS Education, an international operator of PreK-12 schools, is expected to receive \$1+ billion from CVC Capital Partners for a 25% stake in the company

6/3/19: Knowbox, a Beijing-based provider of online homework and test preparation solutions, has raised \$150 million in a Series D funding round from **Alibaba (NYSE:BABA)**

4/25/19: Coursera, an online learning platform offering courses, specializations and degrees, has received \$103 million in a Series E funding round led by **Seek Group**, increasing Coursera's total value to \$1+ billion

6/11/19: BetterUp, a leadership development platform that connects coaches to drive behavioral change in companies, has received \$103 million in a Series C funding round, the largest funding round ever received for an employee coaching platform

5/1/2019: Cengage Learning and **McGraw-Hill** agree to merge to become the 2nd largest U.S. textbook publisher, with a combined valuation estimated at \$5 billion, aiming to restructure product portfolio around digital offerings
